### **BOARD OF SUPERVISOR MEETING 7pm**

### **ZONING AND RELATED MATTERS**

- A. **Kyle and Kayla Bell, 10867 Topper Rd, PIN# 0606-184-8001-0** – Open hearing for rezone request for 3.42 acres from AG to SFR, remnant acreage to remain AG. Ordinance Z2025-1. Discussion followed. Mary Ann Bellazzini made a motion to approve Ordinance No Z 2025-1 (Bell) Town of Blue Mounds, the Town Board of the Town of Blue Mounds, Dane County, Wisconsin, do ordain as follows: That the Town Zoning Maps be amended so that the following parcel in the Town of Blue Mounds, Dane County, Wisconsin, be and are hereby deemed to be approved as rezoning of current Parcel #0606-184-8001-0 (3.42 acres) as follows and that the Zoning Map, Town of Blue Mounds, Dane County, Wisconsin, contain notations and references to this effect: Rezone parcel listed above and defined as Lot 1 on submitted survey as follows: From AG Agriculture Zoning District to SFR Single Family Residential District. Remnant parcel consisting of 28.28 acres to remain AG. This Ordinance shall become effective upon passage and publication. Rick VanDomelen seconded the motion. Motion carried. Kyle Bell also submitted his engineered driveway map. LanAbsentee ballots must arrive by Election Day Spring Election.jpgd Use Committee has already been out to the site. Dennis Jelle signed off on approval to start the driveway process.
- B. **Dennis and Lisa Schlimgen, 2792 Cave of the Mounds Rd, PIN#0606-084-9000-8** – Resident wishes to discuss their new home build, challenges faced regarding building request and email communication with Dane County Treasurer. Dennis and Lisa turned in the Land Use Permit application to build their home. Discussion followed. Mary Ann Bellazzini made a motion that the Town of Blue Mounds Board has determined a split needs to be used for this home build. Rick VanDomelen seconded the motion. Motion carried. Lisa also brought up email communications that she had sent to the Board Members. Discussion followed.
