A. **Kevin Fassbender, PIN# 0606-304-0001-0, County HWY Z -,** Public hearing regarding the splitting of this parcel to create a five-acre residential parcel. Remnant acreage to remain EA. Rezone parcel listed above and defined on submitted preliminary CSM as Lot 2 as follows: From EA, Exclusive Agriculture Zoning District to SFR Single Family Residential District (2.72 acres). Remnant parcel to remain EA Exclusive Agriculture Zoning District (71.27 acres). This Ordinance shall become effective upon passage, publication and delivery of a recorded copy of the CSM to the Town Office. Dennis Jelle seconded the motion. Motion carried.
