

**RESOLUTION OF THE BOARD OF SUPERVISORS OF THE TOWN OF BLUE MOUNDS,  
DANE COUNTY, WISCONSIN**

**Resolution Number 2021- 25**

**Adopting a Ward Plan**

**WHEREAS**, Section 5.15(2)(d) of the Wisconsin Statutes requires all cities, villages and towns to make “a good faith effort” to accommodate county tentative supervisory district plans adopted by the county board following the federal decennial census, and;

**WHEREAS**, on October 14, 2021, the Dane County Board of Supervisors adopted a tentative supervisory district plan that puts portions of the Town of Blue Mounds into two different county supervisory district (District 28 and District 30), and;

**WHEREAS**, Section 5.15(2)(f) of the Wisconsin Statutes allows towns to create wards smaller than 300 people if necessary to accommodate a county supervisory district plan;

**NOW, THEREFORE BE IT RESOLVED**, that the Town of Blue Mounds adopts the wards described as follows:

Ward 1 (Population 850): All portions of the town south of County Highway ID to the Town of Blue Mounds / Town of Perry line, and east of County Highway JG to the Town of Blue Mounds / Town of Springdale line, including the following census blocks:
